1. Course content

"China is Changing the world"

The cultural, economic, geopolitical and environmental impact of the People's Republic of China can hardly be underestimated. To understand major global developments in these fields, we need to understand the influence of China.

"Eight Insights into China" offers essential perspectives into China's profound transformation and its expanding global influence. Students will explore China's economic evolution, ambitious Belt and Road Initiative, and the rapid rise of its digital giants.

The course addresses China's strategic ambitions, political governance, and geopolitical rivalries shaping global security. Environmental challenges and sustainability leadership, alongside China's growing soft power, are also analyzed. Understanding China's demographic shifts and social dynamics further equips participants to grasp China's internal complexities.

This course provides the critical knowledge necessary for future business leaders to effectively navigate and engage with one of the world's most influential nations.

2. Learning objectives

3. Prior knowledge and entry requirements

4. Course structure and dates

- Chinese Tech Giants and Digital Power Exploring the rise of companies like Huawei, Alibaba, and Tencent, their global influence, and implications for international digital governance.
- **China's Economic Transformation** Understanding China's shift from export-driven manufacturing to innovation-led growth, digital economy, and dual circulation strategy.
- **Belt and Road Initiative: Ambition and Controversy** Evaluating the strategic, economic, and geopolitical impacts of China's global infrastructure development projects.
- China's Climate Challenges and Sustainability Efforts Analyzing China's climate challenges, clean energy leadership, and global role in combating climate change.
- The Changing Nature of Chinese Politics Examining the consolidation of Xi Jinping's power, the role of ideology, and implications for governance and stability.
- China's Geopolitical Ambitions and Strategic Rivalries Assessing China's ambition to reshape global governance, its regional assertiveness, strategic competition with the US and other major powers, and its implications for global stability.
- China's Soft Power and Cultural Influence Investigating China's efforts to expand global cultural influence through education, media, Confucius Institutes, and diplomacy.
- **Demographic Challenges and Social Change** Evaluating implications of demographic shifts, aging population, youth unemployment, urbanization, and changing social expectations.
